# **Proposed Bylaws Summary**

The Committee on Bylaws was asked by Grand Master Brenda Hamilton to review the Bylaws of the Grand Lodge of Maryland, and ensure conformance to the Code of General Laws and alignment to the model Constitution and Bylaws for Grand Lodges provided by the Sovereign Grand Lodge. The Committee has merged the previously approved Constitution and Bylaws into the model. Aside from the changes necessary to conform, the following changes are proposed.

- Several spelling, punctuation, and other grammatical corrections
- Fixed pronouns to include women/sisters
- Rewording for conciseness and clarity. No change to meaning or intent.
- Sec 5. Members (of the Grand Lodge)

### • Sec 7. F. Nominations and Elections

(None of the following changes were previously addressed in the bylaws.)

- No election of Grand Master. Deputy Grand Master will automatically rise to Grand Master. (Reason: To allow the incoming Grand Master time to prepare their program with surety of entering office.)
- o Call for nominations must be made three times before closing nominations.
- Nominees must be present at the session, or provide written acceptance of the specific nomination in advance.
- Order of nominations will be: Deputy Grand Master, Grand Warden, Grand Secretary/Treasurer (If needed), Grand Representative, Alternate Representative, Trustees, Others.
- Ballots shall be read out loud before the body. The teller appointed by the Grand Master shall keep official count and declare the final result to the Grand Master.

- Installing Staff shall be chosen by the incoming Grand Master prior to the Annual Session.
- Emeritus Status
  - A member is eligible for Emeritus status after serving four (4) terms in any single office, demonstrating exemplary service to the Jurisdiction through that Office.
  - A resolution outlining the special achievements relating to the office, during their time in office, must be submitted and adopted at the Annual Session by majority vote.
    - The resolution must be signed by at least five (5) Past Grand Masters within the jurisdiction in order to be presented.
  - There shall be no limit on Emeritus statuses bestowed upon any one member.

#### Current

"The Grand Officers elected shall be installed at the pleasure of the Grand Lodge at some time during the Annual Session by the Grand Master or a Past Grand master. Should any elective or appointive Grand Officer not be present at the time of installation, he may be installed at a Special Session called for that purpose. If the Grand Master Elect is to be installed at such special session, the senior Past Grand Master present shall install him. In such an event, the Deputy Grand Master shall act as Grand Master, until the Grand Master is installed. Should any elective Officer fail to appear at the time set for installation and his absence is not excused by the Grand Lodge, the office shall be declared vacant and shall be filled by a majority vote of the Members present. The installation may be either public or closed as the Grand Lodge may decide."

### Proposed

"Grand Lodge officers shall be installed immediately following the annual session in which they were elected. The incoming Grand Master shall decide, at least thirty (30) days prior to the Annual Session, the Form of Installation (Public or Closed), and inform the incoming staff."

"Officers who are not present for installation, and who have not been installed by the first meeting of the Board of Grand Lodge Officers, shall be installed at that time. If any Officer has not installed by the close of the first meeting of the Board of Grand Lodge Officers, the office will be declared vacant, and filled according to "Section 9. Vacancies in Office of"."

#### • Sec 30. – Amendments

#### Current

"This Constitution or any part thereof may be altered, amended, or repealed at an Annual Session by a two-thirds affirmative vote of Representatives present. Any proposition to alter, amend, or repeal must be proposed in writing at an Annual Session by at least five Past Grands from as many different Lodges, which proposition shall be entered on the minutes and shall be acted upon at the next Annual Session; provided also that when the Grand Lodge provides for the appointment of a Committee to prepare a revision or revision or amendments, the report of the Committee may be considered and acted upon at the Annual or Special Session to which it is submitted. Code changes adopted by The Sovereign Grand Lodge shall be edited into the Grand Lodge Constitution and By-laws as mandated without layover."

"Any amendment necessary to conform to the Constitution and Laws of the Sovereign Grand Lodge may be offered and adopted at any session. When an amendment is adopted which conflicts with any part of the Constitution not so amended and a clerical change is thus made necessary to make this instrument conform to the amendment adopted, such change or changes may be made by a majority vote of the Members present. A proposition to amend this Constitution may be amended when under consideration provided it does not add or materially alter the original intent thereof."

### Proposed

"Any proposition to alter, amend, or repeal must be submitted to the Grand Secretary in writing more than forty-five (45) days prior to the Annual Session to be distributed and included in the Advance Report. Any submitted proposition shall be voted on at the Annual Session to which it was submitted, after proper review and report from the appropriate committees. No Bill shall become law unless two-thirds (2/3) present and voting shall vote in its favor. Any proposition, to alter, amend, or repeal that is submitted on the floor at the Session, will be distributed to the appropriate committees, and acted on at the next Annual Session.

Any amendment that does not alter the original intent, and does not conflict with the Code General Laws, can be acted on at the same Session, with a majority in favor needed to amend. The bill shall require two-thirds (2/3) present and voting to be adopted.

Code changes adopted by The Sovereign Grand Lodge shall be edited into the Grand Lodge Constitution and By-laws as mandated without layover.

Should any part of this Constitution and Bylaws become in violation of the Code of General Laws, it must be struck, amended, or changed, immediately, without vote of the membership.

If any change requires creation of a new law, it shall be proposed at the Session by the Committee on Legislation, and adopted by

two-thirds (2/3) present and voting. If two- thirds (2/3) majority cannot be reached, amendments must be proposed until a
conforming bill is passed.
When any change is made to the Constitution and By-laws, a new, full, electronic copy of
the Constitution and By-laws shall be sent to
all Secretaries, Representatives, Grand Lodge
Officers, and Past Grand Masters."

### • Sec 31. - Membership (added)

- Membership shall be as defined in Chapter III of the Code of General Laws of the Sovereign Grand Lodge.
- Change of Classification. Members shall request a change of membership classification with the Secretary of their lodge at the time of paying dues for the upcoming year. The change shall take effect at the start of the new year.
- Lodges may offer non-contributing membership to its eligible members as defined in the Code of General Laws.
- The Grand Lodge does not permit Life Membership within the Jurisdiction.
- The Grand Lodge permits Associate Membership in all component units within the Jurisdiction regardless of explicit mention in their bylaws. If not otherwise outlined by the bylaws of the lodge, dues shall be ten (10) dollars.

### • Sec 32. - Meritorious Service Jewel (added)

- Shall be awarded as outlined in Chapter XXVIII of the Code of General Laws of Sovereign Grand Lodge.
- A resolution outlining the member's exemplary contributions to the Order must be submitted and adopted at the Annual Session by a majority vote.
  - The resolution must be signed by at least five (5) Past Grand Masters within the Jurisdiction in order to be presented.
